Recommendation

Authorize a single source contract be issued to Water Treatment and Controls in the amount of \$40,000 for the period of November 6, 2018 to November 5, 2019. Purchases will include replacement process control instrumentation equipment, parts and supplies for the water and wastewater treatment facilities.

Background

Water Treatment and Controls is the sole source provider for Wallace & Tiernan/ Seimens/ Evoqua equipment items utilized at the Water and Wastewater Facilities. This equipment includes process control instrumentation, chlorination, de-chlorination and other chemical feed equipment to maintain strict compliance measures in accordance with FDEP permit operating conditions. This equipment has been standardized to maintain recommended spare parts inventory. These purchases are vital to the operations for each facility and for continued monitoring and compliance with Federal and State requirements.

Throughout FY19, replacement and preventative maintenance supplies and equipment will need to be purchased in order to maintain efficient operation and recommended spare parts. Continuous monitoring equipment must be returned to service within three days of failure per permit operating requirements, therefore having reliable equipment and available spare parts on-hand is critical to meeting these requirements.
