### RECOMMENDATION:

Reject the responses to Bid No. 180030-B-CM, Generators, Mobile, Trailer Mounted for the reasons stated in the background.

### BACKGROUND:

The purpose of this contract was to purchase 15 mobile, trailer mounted generators. Bids were received from 10 firms. The three low bidders did not meet the specifications/requirements of the bid and the fourth bid exceeded the budgeted amount.

Walker Miller Equipment	Bid did not meet specification. Bid did not include spare tire as specified and did not include alternates.
Synergy Rents	Bid was not complete. Information was not submitted to confirm that specifications were met. Pricing on alternates was not included.
Pinnacle Central Co., Inc.	Bid did not meet specifications. Bid on a single axle trailer instead of double axle specified.

The specifications will be revised and the bid resolicited.
