SUBJECT: Approve Artistic Services to St. Cate Fine Art for Installation of Naiad Statues

RECOMMENDATION:

That the Board of Commissioners approve either option A or option B for the installation of the Naiads by St Cate Fine Art.

Option A: Without Water Feature

Installation: \$ 24,145.00 Contingency (10%) \$ 2,415.00 Total \$ 26,560.00

Option B: With Water Feature

Installation: \$ 24,970.00 Contingency (10%): \$ 2,970.00 Total \$ 27,940.00

BACKGROUND:

The City of Tarpon Springs purchased a set of four bronze sculptures called the "Naiads" by renowned sculptress Glenna Goodacre, from Sarasota, Florida, for \$75,000 to be installed in the roundabout at the end of the sponge docks on Dodecanese Boulevard. The Board of Commissioners expressed interest in adding a water feature as a part of the installation process. City staff sought out recommendations for artistic installations and met with St. Cate Fine Art. St. Cate Fine Art has extensive experience installing indoor and outdoor fine art exhibits. They come highly recommended by the City of St. Petersburg and Dunedin Fine Art Center.

SCOPE OF WORK:

The purpose of this contract is to install the Naiads in the roundabout at the west end of Dodecanese Boulevard. This work includes transporting and installing the Naiads, pouring a concrete base, installing pavers from Greece provided by the City, designing, building and installing the fountain (if fountain is included), and installing lighting. A rendering of the completed project and guote are attached.


St. Cate Fine Art will choose the Greek stone pavers and stones needed for the base, fountain and seated Naiad from a Tarpon Springs source, to be purchased by the City. The cost of the pavers and stones are not included in the pricing this contract. St. Cate will dig out the base area, pour the concrete, transport and install the Naiads, install the pavers and stone (provided by the City), design and build the fountain (with stone paid by the City) and install the fountain (with pump) with pebbles around the fountain, and furnish and install the lighting on the four existing poles. The fountain will work on a float system so water will only flow when it is needed to replenish the reservoir.

The City of Tarpon Springs, Public Works Facilities Maintenance will take out the ten-foot center area where the Naiads are to be installed and will assist with running the electrical for lights and fountains. The City will also remove and replace the current benches. The Public Services Water Division will run the water to the fountain and install the meter.

Approval is in accordance with Florida State Statute 287.055 artistic services exemption.
