RECOMMENDATION:

Award Bid No. 170104-B-JJ Riverside Drive & Hillside Drive Drainage & Roadway Improvements to Suncoast Development of Pinellas County, Inc., in an amount not to exceed \$50,680.00 for the Public Works Department. Further, reject the bid submitted by YD West Coast Home, Inc., d/b/a YD Contractors, Inc. for the reasons stated in the background.

BACKGROUND:

The purpose of this project is to provide drainage conveyance modifications to alleviate existing periodic flooding that occurs on Riverside Drive, immediately south of Sunset Circle and also at the northwest corner of the intersection with Hillside Drive. Project includes pavement removal, regrading of roadside swales, and installation of new storm pipe and storm inlets. The project is anticipated to be substantially complete within twenty three (23) calendar days from Notice to Proceed. The bid submitted by YD West Coast Home, Inc., d/b/a YD Contractors, Inc. did not include unit prices as required by the bid documents and is therefore deemed non-responsive.


