RECOMMENDATION:

Award File No. 190062-C-JJ, Storm Sewer Cured-In-Place Pipelining (CIPP) (Co-op) to Granite Inliner, LLC through Pinellas County Contract No. 167-0513-CP(DF) in an annual not-to-exceed amount of \$255,000.00 for the period February 12, 2019 through February 26, 2021 for the Public Services Department. Purchase orders will only be issued against approved budgets.

BACKGROUND:

On February 27, 2018 Pinellas County awarded the contract. On December 31, 2018 the County approved a name change. The purpose of this contract is to provide cured-in-place pipelining for pipes located throughout the city on an as-needed, work order basis. An example of the types of projects anticipated includes 2,450 feet of 12-inch sewer line on Safford Avenue from Pine Street to Boyer Avenue (see attached memo). This is a cooperative contract that allows all municipalities within the County and region to utilize the services at the same rates, terms and conditions. This contract may be renewed for one (1) additional two (2) year period.

Subject: Authorize the Use of Pinellas County Contract #167-0513-CP with Granite Inliner,

LLC to Complete Pipe Lining and Associated Services for the Rehabilitation of

Sewer Line.

Recommendation:

To authorize the use of Pinellas County Contract #167-0513-CP with Granite Inliner, LLC to complete pipe lining and associated services for the City's sanitary sewer system in an amount not to exceed \$255,000.00.

Background:

The City's sanitary sewer system requires regular maintenance, rehabilitation, and replacement to maintain reliable function. A highly cost-effective method of rehabilitation is the insertion of a liner within existing pipes as an alternative to excavation and replacement. This can often be multiple times less costly than reconstruction with greatly reduced local impacts.

Pinellas County has completed a competitive selection process for these lining services and has an established contract with Granite Inliner, LLC (contract #167-0513-CP). We are proposing to utilize this contract to complete several projects this year through our current budget.

A priority example of proposed lining with this contract is approximately 2,450 feet of 12-inch sewer line on Safford Avenue from Pine Street south to Boyer Avenue. An inspection of several portions of the pipeline has revealed that the piping is in need of rehabilitation to extend its useful life. The effect on traffic will be minimized to the extent possible.

Other projects will be completed according to priority and remaining funds.

This lining work is currently budgeted in the FY 2019 budget in account# 402-4602-536-63.00.
