

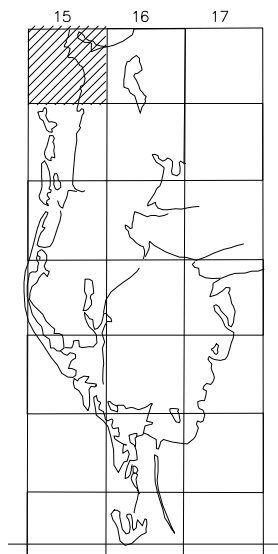
PROPERTY OWNERSHIP MAP

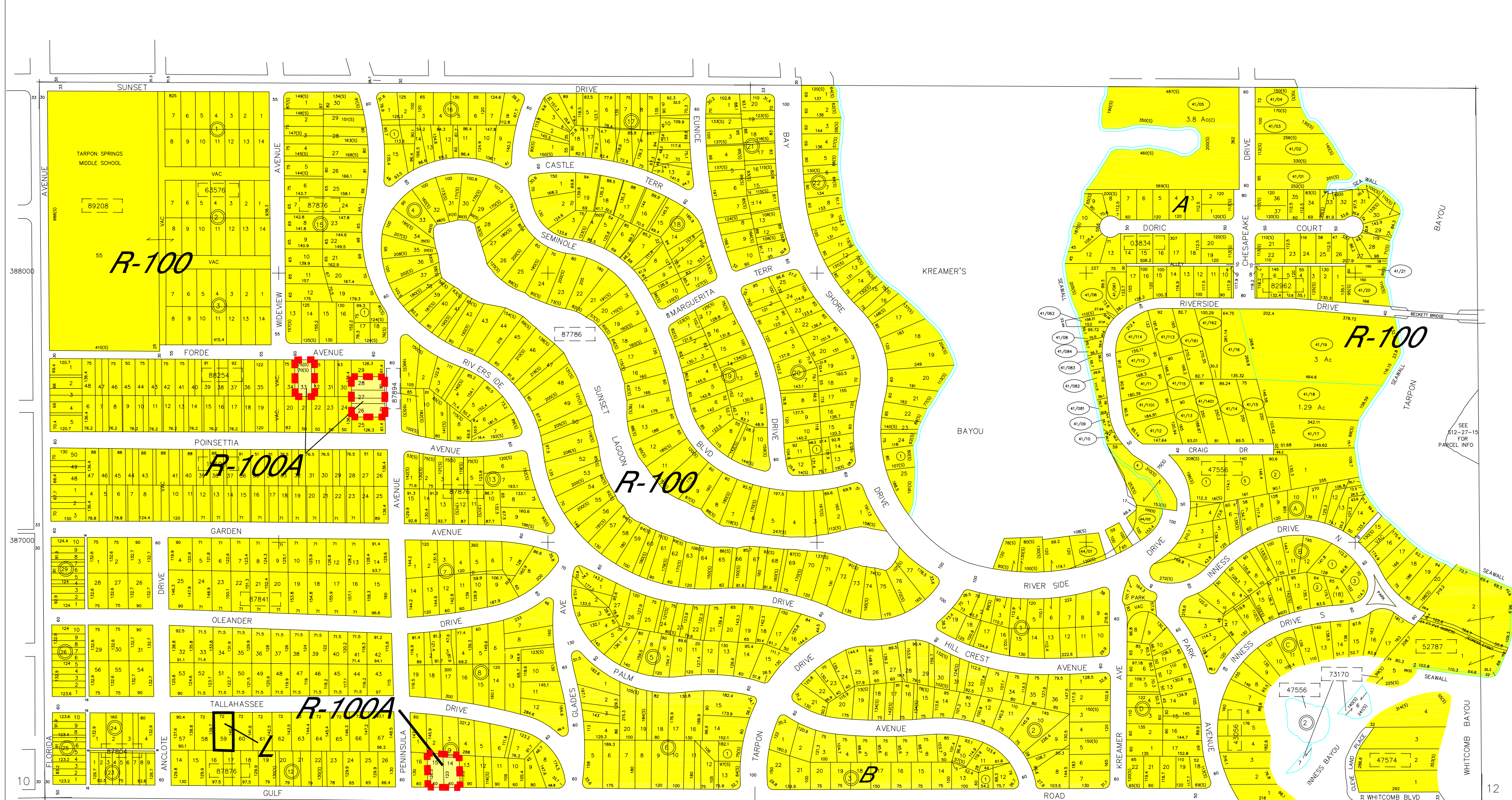
